**Agenda Point – 1**

**Celebration of 135th Birth Anniversary of Bharat Ratna Dr. B.R. Ambedkar.**

**Discussion & Deliberations:**

1. The Board noted that an application was submitted by *Dr. B.R. Ambedkar Samajik Samiti, KV-II, Sector-82, Noida*, led by Shri Matadeen Sagar, on 28.03.2026, requesting permission to celebrate the 135th Birth Anniversary of Bharat Ratna Dr. B.R. Ambedkar on 19.04.2026 and seeking allotment of CC-1 Ground Floor hall without rent.
2. The Board further noted that the said request had already been approved by the AOA office with due intimation to the concerned Police Authorities vide approval dated 09.04.2026.
3. It was also brought to the notice of the Board that another application dated 10.04.2026 was received from a group of residents led by Shri Ravinder Kumar, requesting permission to celebrate the Birth Anniversary on 14.04.2026, being the actual birth date of Bharat Ratna Dr. B.R. Ambedkar.
4. The matter was discussed in detail, considering the sentiments of residents and the significance of the occasion.

**Resolution:**

After detailed deliberations, the Board of Management (BOM) unanimously resolved as under:

- To permit rent-free booking of CC-1 Ground Floor hall to the group led by Shri Ravinder Kumar for celebration of the Birth Anniversary on 14.04.2026.
- The earlier permission granted for celebration on 19.04.2026 shall remain valid.
- This arrangement is allowed as a **one-time exception**.

### Agenda Point – 2

#### Registration on PM Surya Ghar National Portal as GHS/RWA

##### Discussion:

The Board was apprised about the *PM Surya Ghar Muft Bijli Yojana*, under which Group Housing Societies (GHS) / Resident Welfare Associations (RWA) are eligible for a subsidy of ₹18,000 per kW for installation of solar power systems for common facilities, up to a maximum capacity of 500 kW.

It was further discussed that:

- The scheme supports solar installations for **common area electricity consumption** and **EV charging infrastructure**, leading to reduction in electricity expenses.
- The scheme mandates the use of **Make-in-India solar panels**.
- The application and registration process is to be completed through the **National Portal**.

The Board Members discussed the benefits, feasibility, and long-term savings in detail.

##### Resolution:

After detailed deliberations, the Board of Management (BOM) **unanimously resolved** to proceed with the **registration of AOA KV-II Society on the National Portal under the PM Surya Ghar Yojana**.

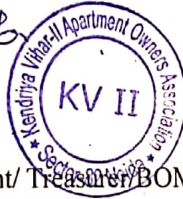
##### Action Point:
