## (i) Registration of Property Dealers for resale and renting of KV-II

Details of all records available in office reveal that 13 property dealers are available with the office. However, out of these listed only 3 were registered up to August 2020. An amount of Rs. 2500/- with 18 per cent GST has been mentioned as registration fees.

BOM unanimously decided to put a full stop for all property dealers in the society as none of them is registered with the society as on date. Only the property dealers who will get them registered would be allowed to operate with in KV-II society.

The BOM unanimously decided to serve the 'notice' to the allottee for termination of allotment of Shop No. 2 at CC1 of KV-II as violation of SI. No. 19 of terms and condition of Auction.
