President welcomed all members to the 4<sup>th</sup> meeting of BOM, KV-II held on 06.09.2025 and requested Secretary to initiate the discussion on agenda points circulated earlier. Meeting started with approving the minutes of 3<sup>rd</sup> BOM meeting held on 06.09.2025.

### Agenda Item No. 1 - Appointment of Auditor for the F.Y. 2024-2025.

As per Bye-Laws 51 the AOA will appoint an Auditor to AGBM to audit the accounts of Association prepared by the Board. The last AGBM held on 7<sup>th</sup> July 2023 appointed Auditor for the F.Y 2023-2024. Due to delay in Elections the AGBM could not be held till date hence appointment of Auditor for the year 2024-2025 is pending. The ITR for the F.Y. 2024-2025 has to be filed on or before 30<sup>th</sup> September 2025. The next AGBM is expected in October 2025 only therefore the BOM is requested to allow the present Auditor to Audit the F.Y 2024-2025 Accounts and file ITR for 2024-25in time. Ex-post-facto approval for this will be taken in the forthcoming AGBM. The BOM unanimously approved the proposal to continue with same Auditor for the year 2024-2025 on same fees and terms & conditions.

#### Agenda Item No.2 - Road Marking---Reg.

The marking on road was unanimously approved vide agenda item no. 3 in 20<sup>th</sup> BOM meeting held on 07.12.2024 but due to Election restrictions and monsoon season the work was delayed. The work was to be completed by the Contractor awarded contract for road re-carpeting Rs 375/+ GST per square meter but the Contractor could not carry out the work after road re-carpeting. Presently, work has been awarded to M/s Alpha Infratech for 600 sq. meter area only (outer ring road and speed breakers only). The In-charge proposed to carry out the road marking on inner roads and open common area parking also.

The horticulture Department of the society needs very hard work and liaising with outside agencies of Centre/UP government and both these BOM members are not able to give their valuable time due to their regular full time engagement with other Government offices, therefore they are relieved of their duties related to Horticulture Department of the Society by the President.
