At the outset, the President, BOM welcomed the Office Bearers and Members of BOM, KV-II for attending the 8th BOM meeting on 15.01.2022. The Secretary, BOM briefed the President, BOM and initiated the meeting as per Agenda items with the permission of the Chair. The decisions taken in the meeting are stated hereunder:

SI. No.	Agenda Items	Decision taken
1.	Confirmation of 7 th BOM meeting minutes.	The BOM has confirmed the minutes of the 7 th BOM Meeting held on 25 th Dec 2021.
2.	Celebration of Republic Day on 26 th January 2022.	The BOM has decided to celebrate the Republic Day on 26 th Jan 2022 in a simple manner due to COVID-19 restrictions. However, the BOM has approved the amount of Rs.10,000/- approx. to meet the expenditure towards the decoration with-in the limited sphere of event.
3.	Termination of Whitewash contract & work to be undertaken in respect of whitewash and painting of grill of boundary of KV II	a. It was deliberated and decided in the meeting that one block of KV II has been left out for white washing, which needs to be completed soon by the existing Contractor engaged for whitewash and painting of common area of KV II. It was also decided that un attended the common area work such as boundary wall white washing and painting of its grill will be carried out separately by the AOA of its own arrangements as the

existing contractor was insisting on increasing the rate under existing contract.

- **b.** Further the BOM has decided to cancel the existing contract of white wash and painting in view of the position explained above.
- **c**. Subsequently, the security deposit of the contractor will be refunded, subject to satisfactory completion report of previous work.
- 4. Finalization of Road Carpeting and Repair Tender.
- a. It was deliberated in the meeting by the Secretary BOM that under his chairmanship two consecutive meetings of Road Carpeting and Repair Committee was conducted, under which the committee has decided to start carpeting and repair work of the road based on the mapping of defective roads which comes around 15,000 square meters. He also deliberated that the Tender Notice has been attempted by the committee considering all aspects in view such as material to be used for construction of roads according to qualitative specifications mentioned in the tender notice.
- b. The Secretary BOM has submitted the draft Tender Notice in respect of road carpeting and it's repair before the BOM during the course of BOM meeting held on 15.01.2022. The BOM while going through it carefully has arrived at conclusion that the Tender Notice to have been prepared has covered entire requirements to fulfill for carpeting and repair of the road within the earmarked location and area.
- c. Accordingly, the BOM has approved the Tender Notice for Public domain through KV II website as well as publication of short notice in a the leading newspaper.
- d. It was also deliberated in the Meeting that the cost of Rs 65 lakhs under Budget allocation on Road Carpeting and Repair has already been approved by GBM in its 9th Meeting held on 23rd September 2018. However the BOM has considered it fit to spend the amount on barest minimal cost, based on the estimated expenditure of Rs 38 Lakhs approx. for the same.

8.	Approval of Payment of Rs 2 Lakhs approx. as lease registration fee in the court in ratio of 50:50 between SBI and AOA. KVII. - 9. To decide the provision of bricks for minor repair and construction in the flats of KV II.
- a. It was deliberated in the meeting that there are the reports from the residents of KVII for illegal construction in the flats either they have started or completed civil/brick work in the common area of KVII, which contravene byelaws of KVII and guidelines/norms of Noida Authority. Therefore, in order to prevent the residents from such an encroachment by illegal construction, the BOM has decided to allow only 100 bricks for minor repair and construction within the flat area. Henceforth, in each case, one time delivery of 100 bricks purchased by the owner of the flat will be authenticated by the representative of BOM before entering KV II. These guidelines will need to be adhered to strictly and scrupulously by each Member of AOA KV II before starting any renovation/construction work.
- b. Further Security Personnel deployed at Gate No.1 of KV-II will maintain brick inward register and will make proper entry of bricks of in respect of Flats. However the Security Personnel will show the register everyday to the AOA Office.
- 10 Rationalization of rate in respect of Maid/Servant in KVII.
- a. It was deliberated in the Meeting that there are reports of irrational rate of services being rendered by the Domestic Helps such as maids/servants in the flats of KV II.
 - b. Therefore, in order to make it rationalised the BOM has decided the rates as follow with effect from 1st February 2022. However, the other services like cooking, full time assistance in flat, washing of clothes etc will be decided between the Domestic Helps and the Residents.
