Approval for extension of terms of contract for Housekeeping Services with M/S Gravity Facilities Management Solution Private Limited, Noida	1.The BOM has decided to extend the terms of contract for Housekeeping Services with M/S Gravity Facilities Management Solution Private Limited, Noida for a further period of one year w.e.f 01.01.2021 to 31.12.2021 on the existing terms and conditions mentioned in the agreement dated 1 st January 2020.
