

(iii) Certificate of successful completion of work in respect of the experience should be issued by an officer not below the rank of Executive Engineer or equivalent. b. The bidder is permitted to use old lift parts like Car guide rails & counter weight guide rails, Counter weight Frame with Filler weights, existing brackets and buffer spring only, if found in good condition after thorough check and their satisfaction and should have residual life of minimum 15 years (Certificate to this effect must be submitted along with the technical bid). All remaining parts of dismantled lifts will be the property of KV-2 AOA.

12. The competent authority on behalf of the Apartment Owners Association of KV-II does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

13. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.

2. 



GENERAL TERMS AND CONDITIONS

1. Suitable scaffolding, temporary barricading in the hoist way and all minor building work etc. required, shall be done by the supplier only. All steel items e.g. machine beams, bearing plates, buffer supports channels etc. at all floors and ladder in pit shall be provided by the supplier.
2. A set of tool kit should be provided by supplier. Operation and maintenance manual and special instruction chart shall be prominently displayed in the machine room. Wiring diagrams shall be displayed inside the panels and in the machine room.
3. The supplying firm shall give a guarantee of 36 months from the date of completion and handing over of the lift work against any material/manufacturing defects. During the period of 12 months, free maintenance comprising of routine/preventive as well as breakdown is also to be carried out including oiling, greasing and checking of all safety devices etc. as required. Any spare parts required for maintenance shall be supplied by the firm free of cost during this period of 36 months.
4. The lift shall be got inspected from the lift inspector by the supplier, if required. AOA shall pay the required fee for this.
5. After successful completion and inspection from the lift inspector (if required), the lift shall be handed over to the AOA, KV-II for putting the lift into service. The certificate issued by the lift inspector will be handed over to the AOA, KV-II.
6. The installation shall be carried out in conformity with the local lifts Act and rules; for example The Bombay Lift Act for Bombay, The West Bengal Lifts Escalators Act for West Bengal, The Bombay Lift Act as extended to Delhi for Delhi etc. At all other places where no local lifts Act exists, the Bombay Lift Act shall be followed. The installation shall also conform to requirements of local Municipal by-laws.
7. All electrical works in connection with installation with electric lift shall be carried out in accordance with the provision of Indian Electricity Act 2003 and Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulations 2010 amended up to date.



CARE OF THE BUILDING
