The President welcomed all Members to the 23<sup>rd</sup> meeting of BOM, KV-II held on 29<sup>th</sup> February 2025 and requested Secretary to initiate the discussions on the Agenda points circulated earlier. Meeting started with approving the minutes of 23<sup>rd</sup> BOM meeting held on 15.02.2025.

#### Agenda Item No.1: Payment for Registration of 52 nos. of New lifts—Reg.

The In-charge Electrical and Lifts informed that the AOA KV-II has taken over 52 newly replaced Lifts and these lifts needs to be registered with Assistant Director (Electrical Safety) Gautam Budh Nagar as per UP lift act. Registration fees of Rs. 5000/- per lift are to paid for this purpose.

2. As per tender document floated by the society for SITC of 120 lifts, the registration fees is to be borne by the AOA, KV-II. 52 lifts has been taken over by the AOA office. At this stage we are in position to apply for registration of 52 lifts and an amount of Rs. 2,60,000/- ( Two Lakh Sixty Thousand only) to be paid to the concerned authorities for this purpose.

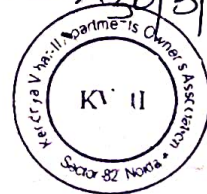
3. The Application process for the registration is being taken care by the ECE Company and the ECE is to be paid the requisite fees by the AOA KV-II.
