The office of Dy Registrar of Societies and Chits Ghaziabad is requested to refer to the letter <u>Letter no. 4602I dated 29.01.2020</u> issued by Office of O/o Dy Registrar of Societies and Chits Meerut, imposing restriction on expenditure to be incurred by BoM of AOA, Kendria Vihar 2, Sector 82, Noida.

2. The record of this society from January 2020 to February 2023 show that regular expenditure on the non- essential works such as Renovation of CC1 ground floor hall with purchase of 12 ACs, Making open Gym with Installation of new machines, Beautification of area near Gate no. 1, unnecessary fencing inside parks, huge expenditure on whitewashing of common area (though incomplete) and painting work in lifts etc. was carried out in society. During this periods BoM were led by Shri OM Prakash Parmar (President) with Shri Kashi Nath as Secretary (from 2019-2021) and Shri Nagendra Singh (President) with Dr. Azeem Khan as Secretary (from 2021 to 2023). These office bearers have not taken approval of AGBM for the expenditure and also violated the above orders of Deputy Registrar. They have done financial irregularities and misappropriation of funds which are serious in nature, hence suitable action as per UP apartment act 2010/ Model Bye-laws 2011 may be taken in larger interest of the society.

Further, the O/o Dy. Registrar vide letter 179 dated 10.05.2024 has also ordered special audit of the year 2021-2022 & 2023-2024 ignoring the years 2019-2020 and 2020-2021 in which these irregularities have taken place. The present BOM accepted the order and requested vide letter number AOA KV-Il/Admin/2024-25/153 dated 29.06.2024 to include the left out periods also and sought approval of rates quoted by the Auditor. The Auditor was asking just double the rates charged by the previous special auditor. Till date no response has been received from the office of Dy. Registrar.

In light of facts mentioned above you are requested to get special audit of the transactions done from January 2020 to February 2023, to safeguard interest of the members of this society.
