## AN APPEAL

**Sub:- To Resolve the pending issue of handing over the temple to the newly constituted committee under the overall control of the Board of Management .**

Dear residents,

During the last six months the BOM has worked on the issue of taking over both the temples, merge both the temples into one and handover the same to an Independent Committee. In this effort the Board has been successful and very soon the temple will come under the overall control of the Board of Management. One important aspect however remains to be accomplished i.e. recovery of financial loss to the AOA, KV-II ever since the temples came into existence. That loss has now been assessed in the following manner. Please understand and react.

1. Board of Management has requested several times to the unruly, illegal group of arrogant people who, instead of handing over the temple premises to the owner i.e. AOA, KV-II, they feel themselves proud that no authority can do anything to them, they are so adamant and they do not understand the seriousness of the issues and taking law in their hand.



2. 5<sup>th</sup> GBM held on 15-11-2009 had decided to charge Rs. 1000/- per day for booking the lawns for religious functions. Board decided to implement this decision and hence the following dues are pending to be recovered from the self proclaimed management group of 21 persons (Annexure-I) without any authority and have illegally captured the temple and share among themselves the offerings, donations being received in the temples. Thus during the last ten years a total sum of Rs. 36,50,000/- has been pocketed by these groups as per the following calculation:

(Rs.1000 per day x 365 days in a year x 10 years=36,50,000/-)

3. Besides above the said group have also been drawing water, security unauthorisedly and was availing the horticulture and housekeeping facility of AOA through out these ten years. If we put value to these expenses, it may come to Rs. 500 per day. Thus the cost for the last 10 yrs would work out as under:-

(Rs.500 per day x 365 days in a year x 10 years= Rs.18,25,000/-)

Hence the total dues pending with the above group comes to Rs. 54,75,000/- (Rupees Fifty four lakhs seventy five thousand only)

4. In the above scenario each individual controlling the temple owes AOA Rs.2,60,714/- per head (Rs.54,75,000 divided by 21 = Rs.2,60,714/-). The Board appeal to these 21 persons (as per Annexure-I) controlling the temple illegally and eating all the collection, cash and kind collectively, to deposit Rs.



2,73,750/- per head in the AOA, KV-II office and collect the receipt by the end of April 2016. Thereafter, Board of Management will be free to initiate action against each of them leading to the cancellation of AOA membership under the clause 7 of the Bye-laws AOA, KV-II. After that they will not be able to contest the election and also not able to cast their votes.

5. Board of management once again request the above group of persons to leave their illegal control of temple and handover the keys to the newly constituted temple committee under the headship of Vice-president, AOA, KV-II without any delay and allow all the residents of Kendriya Vihar to reside in peace and harmony in the colony.
